MINUTES

Council Meeting -April 8, 2020

7:00 p.m. - Council Chambers, Hilton Beach Municipal Office

The meeting was called to order at 7:00 p.m. Present were Mayor Hope, Councillors Davison, Moore, Bailey Meeks and Grant.

DELEGATIONS

1. Tom Desjardin – Pandemic issues

Mr. Desjardin advised that Premier Ford required that all campgrounds be closed with a few exceptions. He noted that three are able to stay in the park as it is their Canadian residence and four are able to stay as they are essential service workers. He noted that their laundromat will open through appointment with cleaning to take place after each use. They are also able to sell propane. This change represents a 90% loss to their business and he noted that the Province is not likely to lift these provisions at any time soon. He submitted a letter from Chris and Cindy Hore who also expressed concerns for the losses to their business. He advised that Algoma Public Health wants people to stay within their catchment areas for the hospital and there have been concerns that people are not following this recommendation. He is hoping that Council will have some form of direction and that they will try to cut costs during this difficult time.

2. CEMC Jerry Shields - Pandemic Emergency Management issues

CEMC Shields advised that there are now 552 persons in Ontario who have tested positive for COVID-19 which is an 11 – 12% increase over the previous day. In the Algoma District area, 9 have tested positive and all of them had recently had international travel so there is no community spread at this time. Most municipalities have closed their municipal buildings but continue to answer the telephone. A few municipalities have declared emergencies which is particularly important if volunteers are needed so that they can be covered by WSIB. Most municipalities have tried to raise awareness and meet with the Emergency Control Group, as needed. One issue that has been a concern is that in the event a case occurs in the Village, we are not provided with specific information regarding that individual. It was noted that if individuals violate the Provincial requirements, it is the O.P.P. who will deal with the enforcement. Canada Border Services and the RCMP can also enforce quarantine issues. With regard to cottagers, a municipality cannot control the movement of people. However, the border will stop people coming in from the U.S.
