# APPOINTMENT OF COUNCIL MEMBER

TAKE NOTICE that the Village of Hilton Beach Council has declared the office of a member of council to be vacant. The Municipal Act permits the vacancy to be filled by appointing a person who has consented to accept the office if appointed or by requiring a by-election.

Although it is the responsibility of the individual to determine whether he or she is qualified to hold office, generally speaking the individual must be:

- A resident of the municipality or an owner or tenant of land there or the spouse of such owner or tenant;
- A Canadian citizen;
- At least 18 years old;
- Not disqualified by any legislation from holding municipal office.
